# Are We Open Yet?

My number one priority is the health and well being of my clients and community...

Hello Everyone!

Governor Whitmer is encouraging that we continue to “telework to the extent possible” and I’ve been busy doing just that! I will be returning to the office on a limited basis June 15th for previously scheduled in-person appointments. As we gradually move into a phase of re-opening I’d like to share what steps I’m taking to create a safe and comfortable visit together:

- \*I will limit sessions to no more than two per day in-office.

- \*In-office sessions are available, but telephone or televideo sessions are encouraged. For my out of state and overseas clients this is nothing new, and YES it works just as well. I’ll meet you via FaceTime or Skype for televideo appointments. Your comfort level and safety during our reading is top priority. When Tricia calls you to confirm your appointment you can go over any questions and options.

- \*Unfortunately I cannot see entire families in-office at present as we practice social distancing. I can see up to two people at a time, however, based on the six feet rule.

- \*No more than one person in the waiting room at a time.

- \*Enhanced cleaning between each client of all surfaces, and doorknobs, as well as a fifteen minute window between each client is in practice.

- \*Hand sanitizer and disinfectant wet wipes are provided.

\*We practice six feet social distancing.

\*Windows are open for fresh air.

\*When you arrive, if you prefer, I am happy to meet you at the front door for complete contactless entry.

\*Please wear a mask

\*If I have a fever, and I'll check daily, I will reschedule you. I ask that you do the same, and please do not enter the office building if you have any Covid 19 symptoms, have been knowingly exposed to Covid 19 in the past few weeks, or exposed to any large groups of people recently. Your health is your, and our wealth!

Lastly, lets remember that we are still in the middle of a pandemic and need to stay cautious. Depending on our state's statistics and mandates we may need to change protocols or return to visiting exclusively via phone or video.

Los Angeles, I will not be in town in August as planned this year. I do miss you and look forward to our in person visits at a later date. In the meantime, I'll talk with you on the phone or see you on televideo, where, by the way, I have seen orbs and things galore that the naked eye doesn't always pick up!
